As DALL members have come to expect, our educational programming was excellent in 2016-2017. Lee Bernstein, First Vice President/President-Elect, led the charge as our Programming Chair.

- In April, DALL's Spring Institute was hosted by the Underwood Law Library at Southern Methodist University.
  - Keynote: Allen Pusey, Senior Editor of the Texas Lawbook, former editor and publisher of the ABA Journal, who spoke on "Fake News: A Love Affair – Why 'Fake News' Is More Dangerous When It Isn't"
  - O Cassie DuBay, Kevin Miles, and Shanna Pritchett Program: Practice-Ready": It's what everyone in the legal field is talking about, from the ABA to private employers. But for academic librarians to effectively teach legal research skills, they need a clear understanding of the research expectations and technologies faced in practice. To bridge this gap, past AALL programs have included conversations between academic, firm, and government librarians discussing research skills, expectations, and more. This program continues that conversation at the local level.
  - O Stewart Caton and Edward Hart Program: Incorporating research instruction into doctrinal classes helps students develop legal information literacy, connecting their understanding of legal information with the law they are learning. Attendees will hear how UNT Dallas College of Law adopted a graduation requirement calling for students to complete research lessons (called research segments) during their upper class studies, and how the librarians partnered with doctrinal faculty to carry out assessments of students.

DALL's networking and social events were well received and well attended by members this year. In Chicago during AALL in July, DALL supported a joint reception with HALL, SWALL, and UNT College of Information. DALL held a December holiday luncheon at the Dallas Chop House that was the best attended event of the whole year. Our May spring social was at Tortaco. The spring social was especially remarkable as it commemorated the end of the 2016-2017 year

and the beginning of the 2017-2018 year. The gavel was passed and the new Executive Board was introduced to the membership.

DALL continued its tradition of supporting a member's attendance to AALL in Chicago by awarding a grant to Jennifer Stephens of HaynesBoone. We recruited two chapter VIPS for the Austin AALL meeting, more details in next year's report.

DALL continued to develop its new website. The new website was designed to be easier to maintain and to provide quick access to critical information to members. It also includes three notable new features the organization determined would be useful to members and DALL administration:

- completely online membership renewal system
- a Research Corner to help members locate research information and submit research tips
- digital access to Advance Sheet archives

DALL continued to publish the *Advance Sheet* under the guidance of Newsletter Editor, Donna Bostic. The organization published the 41 volume of the *Advance Sheet* this year. The newsletter is published electronically only.

Consistent with DALL's history, 2016-2017 was a productive year and the organization continued to focus on programs and initiatives that directly benefit members.
